

PRIVACY STATEMENT ON PROCESSING OF PERSONAL DATA

(DRAWN UP PURSUANT TO ART. 13 OF THE ITALIAN LAW DECREE NO. 196
DATED 30 JUNE 2003 – CODE ON PERSONAL DATA PROTECTION)

To Whom It May Concern

Dear user,

Pursuant to Art. 13 of the **Italian Law Decree no. 196/2003** (Code on personal data protection), treatment of your personal data, further to their lawful collection, either manual or by automated means, shall be performed in compliance with the principles of fairness, lawfulness, and transparency as well as protection of your privacy and rights.

Pursuant to Art. 13 of the Italian Law Decree no. 196/2003, we provide you with the following information:

1. The personal data you voluntarily provided - or we collected - shall be processed within the scope of applicable privacy regulations, for the following purposes, only and exclusively: corporate accountancy and tax system, management of trading relationship and purchase, sale and service contracts, and any obligation envisaged by law provisions, protection of company interests by any lawful means. Treatment of your personal data shall be carried out on hard copy and/or by computer means by in-house personnel only and by any external person lawfully appointed/made accountable to the purpose of personal data processing.
2. Provision of personal data is mandatory to let the Company send marketing information, offer services requested by you and available on Company website, and fulfil any and all law, accountancy and tax requirements at Company charge; any refusal to provide personal data hereof may result in failure, in full or in part, to execute the service or the supply by **FRA**[®] PRODUCTION S.p.A. . Provision of other personal data, which are not strictly necessary to pursuing corporate purposes, is optional and aimed at allowing the Company to inform and update you about new products and services.
3. Please note that any personal data that can disclose a person's racial origin or ethnicity, religious, philosophical or other beliefs, political opinions, membership of parties, trade unions and/or religious, philosophical, political or trade union associations and/or organizations, as well as any personal data that can disclose a person's health, and/or sex life, and any data concerning health, are sensitive data. Sensitive data, together with any judicial data you spontaneously provided, shall not be processed without your prior written consent.
4. Subject to your prior consent, data shall be disclosed to third parties (companies, entities or associations) that share the purposes intended by **FRA**[®] PRODUCTION S.p.A. and shall carry out data processing as Data Processors, provided they adopt any security measures set forth by law provisions.
5. Pursuant to Art. 28 of the Italian Law Decree no. 196/03, Data Controller shall be **FRA**[®] PRODUCTION S.p.A. , at company administration and operation offices.
6. Data processing shall be carried out at the aforementioned offices by entrusted personnel only and exclusively.
7. Pursuant to Art. 7 of the Italian Code on personal data protection, you shall be entitled to exercise your rights against Data Controller at any time; specifically, you shall be entitled to know any processing concerning your data; to promptly obtain any communication on data hereof and the relevant origin in an intelligible form, and deletion, conversion into anonymous form or blocking of any data unlawfully processed. Furthermore, you shall be entitled to data updating, amendment or integration; certification that the aforementioned operations have been brought to the attention of and acknowledged by anyone to whom the aforementioned data have been communicated, unless the aforementioned requirement proves to be impossible or involves a manifestly disproportionate effort compared with the right to be protected; to object, in full or in part, on legitimate grounds, to the processing of personal data concerning you, even if they are consistent with the purpose of data collection.
